Project Summary and Highlights

Summary

The Hauxley Hide & Trail Renovation project helped improve 2.4 km of water environment at the Hauxley Wildlife Discovery Centre, managed by Northumberland Wildlife Trust, through enhancing the accessibility, visitor experience, and habitats of the site to deliver bluespaces for the public. This was achieved through creation of a new bird hide offering exceptional views over wetland habitat, tree planting, installing a new brass rubbing trail along the accessible trail, and drainage improvements to improve the accessibility of the circular footpath route.

Highlights

- New Ponteland Bird Hide now more accessible and safe to use for visitors
- Approximately 300 trees planted at the site to enhance the shelter belt to provide new habitat for both resident and migrant bird species
- A new wetland-themed brass rubbing trail created for families to attract users to the accessible trail through the site
- Drainage enhancements will now allow the circular footpath to remain open year-round
- Creation of extra wetland features on-site linked to drainage improvements




Figure 1: Bluespaces improved at Hauxley Wildlife Discovery Centre

Project Outputs, Benefits & Evidence Against Criteria

Access, Facilities & Recreation

Expected Project Outcomes

- The old Ponteland bird hide will be replaced with a new, fully accessible hide, including raising the path leading to the hide for wheelchair access.
- Install new 'brass rubbing trail' with wetlands theme along the accessible trail, allowing all reserve users to participate and engage visitors with the water environment.
- Improve the circular route by draining the wettest 50m of footpath. This will improve accessibility, visitor experience, and prevent more path closures in future.

Outputs

- A new replacement Ponteland hide was constructed, offering a much safer and more accessible facility from which to enjoy the water environment. The path to the hide was raised, the door is wider and there are now seating areas for wheelchair users.
- 2. A new wetland-themed brass rubbing trail was installed along the accessible visitor trail, including 9 brass rubbing posts, and a leaflet to be used by visitors. The brass-rubbing trail is advertised on the Hauxley Reserve page of NWT's website, informing visitors that the leaflet and a pack of crayons can be purchased (£1) from the Lookout Café on site. By 30/12/24 174 packs had been sold and a further 94 given out as part of school and community group engagement.
- 3. Ditching work and culvert installation was conducted in autumn 2024. In the previous winter, the footpath was closed from October 23 until March 24 due to flooding. By the end of December 24 the drainage was working well, and the footpath has remained open to visitors.

- Increase the area and diversity of scrubby woodland on the coastal edge of the site, a valuable habitat for migrants such as long and short eared owls, brambling, fieldfare, goldcrest and woodcock making landfall from Scandinavia. Currently the woodland is dominated by mature sycamore that has been periodically thinned and
- Drainage works to improve the circular route footpath will divert more water into wetland areas, providing more wetland habitat for wildlife.

Outputs

- 1. Approximately 300 trees were planted at South Wood, on the coastal edge of the site, including willow, alder and hazel, to enhance the diversity and age structure of the scrub / woodland shelter belt. The sycamore monoculture will be gradually thinned over the years once these trees begin to establish, helping to further reduce the domination of the sycamore species.
- 2. Drainage works to improve the circular route footpath have allowed creation of two new ponds downstream of the culvert, providing more wetland habitat for wildlife to utilise.

Customer Testimonies & Media

Northumberland Wildlife Trust struggled to get useful feedback from visitors, with comments received usually being 'it's great' 'it's nice' etc. Therefore, they asked their reception team to ask visitors for comments specifically on the Bluespaces works (Hide, Footpath and Rubbing Trail), and why they thought it was good. Visitors were encouraged to say more than the standard 'it's great'. They didn't include negative comments about the reserve such as 'the new hide is brilliant but there aren't any birds', 'why didn't you do the boundary path in stone' and other comments that were not linked to this project.'
